

Hon'ble Vice-Chancellor desired that the quality of research should improve and efforts should be made to pursue such research themes that have direct relevance to society. After due deliberations following observations/remarks were made to be complied with:

1. It was felt that the Research Centres such as Centre of Central Asian Studies (CCAS) should undertake focused and quality research work that distinguishes them from the related teaching departments.
2. It was also observed that multi-disciplinary approach to research investigations needs to be promoted in the Centre so that the research is more holistic, meaningful and all the relevant facets of a research problem are adequately addressed.

3. It was emphasized on Director, CCAS to explore possibilities of having co-supervisors from the Central Asian countries/regions of interest in order to enhance the quality of work and promote academic collaborations with institutions of repute in the Central Asian region.
4. Director, CCAS was cautioned against any repetition of work for which he was advised to seek necessary inputs from the concerned departments/Centres/teachers.
5. It was reiterated in meeting that there shall be a single entrance test for admission to M.Phil/Ph.D programme to a subject/discipline to be conducted by the Dean of the School in which the subject/s fall/s.
6. It was also highlighted that the statutes governing Ph.D and Integrated Ph.D programme be strictly adhered to, particularly, in respect of the requirements of assessment of work progress in accordance with the provisions of the aforementioned statutes.


