With reference to your application for the Maulana Azad National Fellowship for Minority Students, I am happy to inform you that based on the recommendations of the Expert Committee; the UGC has selected you for the Maulana Azad National Fellowship for Minority Students, for the year 2016-17.

The tenure of the fellowship is for five years and it commences w.e.f. 1.4. 2016 (or) from the date of Registration under M.Phil / Ph.D. (or) from the date of joining in M.Phil / Ph.D. programme, whichever is later. 
