Based on the recommendations of the Selection Committee and subsequent to the approvals of the Competent Authority, sanction is hereby accorded the appointment of Dr. Imtiyaz Ahmad Dar as Assistant Professor (UR) on substantive basis in the Department of Kashmiri in the Academic Level-10 (Rs. 57,700 – 1,82,400) of 7th CPC Pay Matrixto be fixed as per the Gol norms on the following terms and conditions:

- Usual allowances (DA, HRA & other benefits) as admissible on the pay under the rules of Government of India shall be applicable to him from time to time.
- He shall be placed under probation for a period of One Year from the date of joining the University, which is
 extendable by a further period of One Year. At the end of the aforesaid One Year, his work will be assessed to
 adjudge his suitability for confirmation in the services of the University.
- 3. He shall be governed by the New Pension scheme (NPS) as per norms laid down by the Government of India.

- He may be assigned other responsibilities by the University as and when required in addition to his own duties.
- 8. He may leave the service of the University as per the University norms and Regulatory bodies.
- The appointment is subject to the verification of antecedents from the appropriate authority for which he shall have to fill up the prescribed form.
- Without prior approval of the Competent Authority, he cannot accept any other job or get involved in any trade or business or accept any offer of project or involve in any activity as may be forbidden by law.
- While accepting the appointment, he must inform in writing and furnish full details of applications already submitted by him for posts in other organizations and full details of any examinations he has appeared for.
- 12. He is expected to exhibit academic honesty, high moral and ethical values in the University and outside.
- His general service conditions shall be governed as per Central Civil Services (Conduct) Rules, 1964 & amendments thereof.
